The attention of the all the HoDs under the Control of HM&FW Department are invited to the references cited.

2. In the reference 1<sup>st</sup> cited above, the Commissioner of Health & Family Welfare, A.P. has sent a proposal to the Government for according permission to conduct limited recruitment for filling up of the backlog vacancies (424) and to convert as open category points as per the provisions contained in AP State and Subordinate Rules,1996 since the vacancies were notified earlier in different notifications.

3. Accordingly, the proposal was placed before the Inter-Departmental Committee which was held on 17.03.2022. The Committee after detailed deliberation on the issue has opined the following rule position with regard to conversion of posts:

*If in any recruitment, qualified candidates belonging to the Scheduled Caste, Scheduled Tribes, Backward Classes (Group-A), (Group-D), (Group-C), (Group-D) and as the case may be (Group E), Women are not available for appointment to any or all the vacancies reserved for them, a limited recruitment confined to candidates belonging to them shall be made immediately after the general recruitment to select and appoint qualified candidates from among the persons belonging to these communities to fill such reserved vacancies.*

*If in any recruitment, qualified candidates belonging to Scheduled Castes or Scheduled Tribes or Backward Classes (Group-A), (Group-B), (Group-C), (Group-D) and as the case may be (Group E) or women are not available for appointment to all or any of the vacancies reserved for them even after conducting a limited recruitment as specified in sub rule (g) of rule-22 of AP State and subordinate service rules-1996, such vacancies or vacancy may be allotted to the open competition after obtaining the permission of the Government and may, thereafter, be filled by candidates selected on the basis of open competition.*

*Where any vacancies reserved for the Scheduled Castes or Scheduled Tribes or, Backward Classes (Group-A), (Group-B), (Group-C) and as the case may be (Group-D) or Women are so filled by candidates belonging to other communities, an equal number of vacancies shall be reserved in the succeeding recruitment for the Scheduled Castes or Scheduled Tribes or, Backward Classes or Women in addition to the vacancies that may be available for that recruitment for them and if in the said succeeding recruitment year also, qualified candidates belonging to the Scheduled Castes or Scheduled Tribes or, Backward Classes (Group-A), (Group-B), (Group-C) and as the case may be (Group-D) or Women are not available for appointment all or any of the additional vacancies which are so reserved in that succeeding recruitment year, an equal number of vacancies shall again be reserved in the next succeeding recruitment year for the Scheduled Castes or, Scheduled Tribes or, Backward Classes (Group-A), (Group-B), (Group-C) and as the case may be (Group-D) or Women in addition to the number of vacancies that may be available for the next succeeding recruitment for the Scheduled Castes or, Scheduled Tribes or, Backward Classes (Group-A), (Group-B), (Group-C) and as the case may be (Group-D) or Women.*

:2:

*Provided that if in the said second succeeding recruitment also no qualified candidates belonging to the Scheduled Castes or Scheduled Tribes or Backward Classes (Group-A), (Group-B), (Group-C) and as the case may be (Group-D) or Women are available for appointment to all or any of the additional vacancies which are so reserved in that succeeding recruitment year, an equal number of vacancies shall again be reserved in the next succeeding recruitment year for the Scheduled Castes or, Scheduled Tribes or, Backward Classes (Group-A), (Group-B), (Group-C) and as the case may be (Group-D) or Women in addition to the number of vacancies that may be available for the next recruitment for the Scheduled Castes or Scheduled Tribes or Backward Classes or Women.*

*Provided further that in the third succeeding recruitment if qualified candidates belonging to Scheduled Tribes or as the case may be Scheduled Castes are not available, a vacancy reserved to be filled by a candidate belonging to Scheduled Tribes may be filled by a candidate belonging to Scheduled Castes and a vacancy reserved to be filled by a candidate belonging to Scheduled Castes may be filled by a candidate belonging to Scheduled Tribes and if a qualified candidate belonging to a particular group of Backward Classes (Group-A), (Group- B), (Group- C) and as the case may be (Group-D) is not available for appointment. the vacancy reserved to that group shall accrue to the next group.*

4. All the HoDs under the control of HM&FW Department are therefore requested to take further immediate necessary action to issue limited recruitment notification for the unfilled roster points and take further action as per the rules.



- 1.3. The filled-in applications along with necessary documents shall submit at office of the District Coordinator of Hospital Services (APVVP), Government General Hospital campus, Ananthapuramu.
- 1.4. The selection to the posts will be on the basis of final general merit cum rule of reservation.
- 1.5. The applicant is required to visit the Ananthapuramu District official website regularly to keep himself/herself updated until completion of the recruitment process. The website information is final for all correspondence. No individual correspondence by any means will be entertained under any circumstances.
- 1.6. All desirous and eligible candidates shall apply after satisfying themselves as per the terms and conditions of this recruitment notification. **PARA: 2 :: Educational (Academic & Technical) qualifications to various posts :**

- 3.1. There will be Local / Non-local reservations will be followed as per guidelines
- 3.2. Rule of reservation will be followed as per rules in force.
- 3.3. Evaluation of various Physical Disabilities and procedure for certifications will be as per order contained in G.O.Ms.No.56, WD,CW&DW(DW) Dept., Dt.02.12.2003 and G.O.Ms.No.31, WD,CW&DW(DW) Dept., Dt.01.12.2009.

**04) Reservation to Local candidates :**

- 4.1. Reservation to the local candidate is applicable as provided in Article 371-D as per G.O.Ms.674, GA(SPF-A) Dept., Dt.20.10.1975 and rules amendment from time to time and as in force on the date of notification. The candidate claiming as local candidates should obtain the required study certificates (from 4<sup>th</sup> class to 10<sup>th</sup> class or SSC) or Residence Certificate in the proforma prescribed for those candidates who have not studied in any Educational Institutions as the case may be. The relevant certificate with authorize signature shall be produced as and when required.

**07) Important note on Recruitment process and procedure of selection :**

- 7.1. The recruitment will be processed as per this notification and as per the rules and instructions issued by the Government and also as decided by the District Selection Committee, Ananthapuramu from time to time in terms of respective Special Rules/Adhoc Rules governing the recruitment and the related G.Os, rules etc., are applicable.
- 7.2. The various conditions and criteria prescribed herein are governed by the AP State and Subordinate Rules 1996 read with the relevant special rules applicable to any particular services in the departments. Any guidelines or clarifications are

based on the said rules, and in case of any necessity any matter will be processed as per the relevant General and Special Rules as in force.

#### **08) Tenure of appointment and important conditions :**

The tenure of the contract/out-sourcing initially one year from the date of joining in the post and may be extended for further period as per the instructions issued by the Government from time to time.

The District Selection Committee; Ananthapuramu reserves all the rights to terminate the contract/outsourcing services of any candidate/candidates at any time without giving any prior notice as per directions of the Government from time to time.

#### **09)Debarment :**

Candidates should make sure of their eligibility to the post applied for and that the declaration made by them in the format of application regarding their eligibility is correct in all aspects. Any candidate furnishing in-correct information or making false declaration his/her eligibility at any stage or suppressing any information, is liable to be debarred up to 5 years from applying for any of the notifications conducted by APPSC/District Selection Committee/any other recruiting agencies and their candidature for this recruitment summarily rejected.
