Pune Metropolitan Region Development Authority is implementing the 23.203 km Pune Metro Line 3 connecting Rajiv Gandhi IT Park at Hinjawadi to city centre Shivajinagar on Public Private Partnership mode. The metro is fully elevated and has 23 stations. The total Project Cost of the project is Rs. 8313 cr. The PPP work has already been awarded to the Concessionaire company & the Appointed Date was declared on 25.11.2021. The work of the Metro Project has started and is expected to complete within 40 months.

PMRDA intends to establish a Project Management Unit (PMU) for effective monitoring and execution of the Pune Metro Line 3. PMRDA intends to appoint qualified and experienced professionals for the following posts on Deputation basis/ Contract basis:

Terms and Conditions of Contract Appointment:
